GENERAL INFORMATION

The Paradise Downtown Business Association invites non-profit community services organizations, craft vendors, farmers, and general vendors to participate in the 2008 Paradise Downtown Street Fair and Farmers Market. The 2008 Street Fair events are scheduled on Wednesday's beginning June 11 until August 13 between 6PM and Dusk on Fir Street (between Skyway and Almond) in Paradise.

Applications submitted are not guaranteed a position. A committee will review all entries.

Vendors and exhibitors may rent a 10' x 10" outdoor space in a designated area to sell goods from 6PM to Dusk. Vendor set-up will be from 5pm to 5:45pm. Fees for renting an outdoor space without electricity are as follow:

VENDOR SPACE RENTAL COST:

\$30.00 for each night

\$200 for all 10 nights

ALL VENDOR SPACE FEES are due with the application along with a photograph of the products being sold. The following types of payment are accepted: check, or money order, cashiers check or cash, make checks out to Paradise Downtown Business Association.

RULES FOR PARTICIPANTS:

- 1 All equipment, merchandise and display items must be kept inside vendors assigned booth space.
- 2 At least one person must remain within their assigned booth space during the designated event hours.
- 3 Booth take down may not begin until the Street Fair Director announces the close of the market
- 4 All vendors are responsible for clean-up of their own debris after closing.
- 5 Vendors are responsible for following the rules and regulation, the laws of the State of California, the Town of Paradise and Butte County.
- 6 Vendor Fees are non-refundable, no exceptions.
